

THIS CHARITABLE CONTRIBUTIONS CHEAT SHEET IS MEANT TO HELP YOU WITH CALCULATING YOUR NON-CASH DONATIONS PROVIDED YOU HAVE CONTRIBUTIONS IN EXCESS OF \$500.

FOR CONTRIBUTIONS LESS THAN \$500 THERE IS NO NEED TO PROVIDE THE FOLLOWING INFORMATION.

INFORMATION NEEDED:

- > NAME OF CHARITY
- > ADDRESS
- > DATE DONATED
- > DATE ITEMS BEING DONATED WERE PURCHASED
- > ESTIMATED COST OF ITEMS BEING DONATED WHEN FIRST PURCHASED
- > ESTIMATED VALUE OF ITEMS WHEN DONATED
(see attached sheet for estimates)

Donors interested in claiming tax deductions should keep itemized lists of their donations. The Internal Revenue Service allows a deduction for each item, but the donor determines each item's value. Generally, an item's value should be based on fair market value.
